REPORT FROM COUNCIL PRESIDENT, JOE MARTIN

Council met on October 17, 2024. Council discussed a report provided by the investment committee and asked them to investigate a couple of options that they had suggested to provide a better return on the church investments and report back to council.

It was reported that the painting and storm window projects are complete and everyone noted how nice the church looks. Fire doors are soon to begin being installed as requested by the 2023 state fire inspection.

Council also reviewed the proposed 2025 budget as provided by support.

WELCA

WELCA is collecting winter hats, gloves and mittens for children in need in our community. These items may be brought in throughout the month of December, and can be placed in the designated basket in the narthex.

CHURCH DIRECTORY UPDATE

The new Church Directory is almost completed! It will be ready to distribute soon! We will have an electronic version, as well as hard copies, and will let you know as soon as they are ready!

CALL COMMITTEE (REPORTED BY STEPHEN GRING, CHAIR)

The Call Committee met on October 24 at which time the committee discussed a strategy for conducting interviews with prospective applicants. The committee members decided upon areas of interest ranging from the spiritual to the financial. After a very open discussion, committee members felt better prepared to conduct an interview.

There was some confusion in communication regarding the filing of the Ministerial Site Profile; the Committee reviewed the requested changes that the bishop had requested at her meeting in September. In fact, these changes were

electronically recorded on September 20. Chris Dennis, Call Committee Secretary, resubmitted the MSP; we immediately received an electronic confirmation that the updated MSP had been received (again!). The Synod subsequently affirmed this. The application process is now activated. The Committee awaits receiving an applicant.

At the same meeting, Stephen Gring, the current Chair, announced he will step away from the Chair position on January 1 due to other outside obligations; he will remain a member of the Committee. A new Chair will be nominated from within the current committee membership.

SUPPORT COMMITTEE-GIVING WITH GRACE

In the last episode we discussed the gift of <u>CASH</u>. Cash is the easiest and quickest way to benefit Grace and get an immediate tax benefit for ourselves. We accumulate asset to provide income to tide us through that time when we no longer can or want to work for income. Sometimes we accumulate more than is necessary. When we have excess appreciated assets, however, we merely create unwanted tax obligation when sold or given to heirs.

Appreciated Securities:

An outright gift of Appreciated Securities to Grace creates substantial tax benefits to the giver. As an example, if you were in the 33% tax bracket and contributed \$10,000 worth of appreciated stock to Grace, you would realize a \$3,300 tax saving. Moreover, if you paid \$3,000 for the stock at least 12 months ago, you would also avoid a capital gains tax of \$1,050 (15% of \$7,000). Thus, the actual cost of the gift of long term appreciated assets to Grace, can be reduced to only \$5,650 (\$10,000 less the income tax saving of \$3,300, less the capital gains tax saving of \$1,050).

We have not talked about creating an income stream using those same appreciated assets. That is somewhat more complex but even more beneficial. We will save that topic for a future discussion. Next installment will discuss how gifts of **Tangible Personal Property** can benefit you and Grace at the same time.

As with all tax and investment advice, before you adopt any strategy outlined in these discussions, you should consult your own tax and financial advisors as to how the strategy fits into your own situation.


